- a) Shall be a person not less than 35 years of age.
- b) Be a Post – Graduate either in Social Welfare, Psychology, Child Development, Education, Sociology, Law, Criminology.
- c) A teacher, doctor or a social worker who has been involved in work, concerning children
- d) Should have experience in their respective field to a minimum of seven years.

The tenure of Chairperson and members shall be co-terminus with the tenure of the Committee.

The chairperson, other members and Social Workers thus selected will be purely appointed in a honorary basis for a tenure of 3 years and will be paid only travel and sitting allowance. 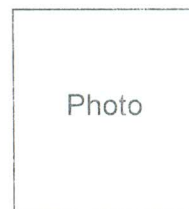
